Notice is hereby given as required by Title 5, Chapter 551.041 of the Government Code that the Northlake Town Council will meet in a Regular Meeting on February 23, 2023, at 5:30 p.m., at the Northlake Town Hall in the Chamber Room, 1500 Commons Circle, Suite 300, Northlake, Texas 76226. The items listed below are placed on the agenda for discussion and/or action. Town Councilmembers may appear virtually via video conference pursuant to Texas Government Code § 551.127. The following items will be considered:

3. PUBLIC INPUT

A. This item is available for citizens to address the Town Council on any matter. The presiding officer may ask the citizen to hold his or her comment on an agenda item until that agenda item is reached. By law, no deliberation or action may be taken on the topic if the topic is not posted on the agenda. The presiding officer reserves the right to impose a time limit on this portion of the agenda.

C. Consider a Resolution of the Town of Northlake, Texas, approving an Escrow Agreement and a Cost Sharing Agreement between the Town of Northlake and Northlake Municipal Management District No. 1 (MMD No.1)

5. **ACTION ITEMS**

- A. Consider a Resolution of the Town of Northlake, Texas, approving and authorizing the Town Manager to execute an agreement/contract with Halff Associates, for Preliminary Design and Construction Plans of the Catherine Branch Wastewater Treatment Plant Expansion, in an amount not to exceed \$416,900
- B. Consider a Resolution of the Town of Northlake, Texas, approving and authorizing the Town Manager to execute a development agreement with Petrus Investment, L.P., for the development of the proposed Hillwood Industrial Park Concept
- C. Consider a Resolution of the Town of Northlake, Texas, appointing a member to the Comprehensive Land Use Plan Steering Committee
- D. Consider a Resolution of the Town of Northlake, Texas, approving and authorizing the Town Manager to execute an agreement/contract with Retail Street Advisors, for a market study to develop a mixed-use master plan for the Chadwick Farms commercial frontage referred to as Chadwick Commons, in an amount not to exceed \$75,000; and approving the Northlake Community Development Corporation Board of Directors and Northlake Economic Development Corporation Board of Directors recommendation to fund 50% of the cost (\$18,750 from each board respectively)

6. **EXECUTIVE SESSION**

The Town Council will convene in an Executive Session, pursuant to Texas Government Code, annotated, Chapter 551 Subchapter D:

A. Section 551.071 - Consultation with Attorney

The Town Council may convene in an executive session to consult with its attorney to seek advice on a legal matter. It provides as follows: A governmental body may not conduct a private consultation with its attorney except: (1) When the governmental body seeks the advice of its attorney about: (a) pending or contemplated litigation; or (b) a settlement offer; or (2) on a matter in which the duty of the attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with this chapter. The Town Council may adjourn into executive session for consultation with the Town Attorney regarding:

- Potential development agreement and annexation of the DFW Northlake Business Park LLC tract on approximately 67.7-acre tract of land generally located north of FM 407 and 1,200 feet east of Faught Road in the extraterritorial jurisdiction of the Town.
- ii. Potential lease agreement with tenant of proposed sports venue.
- iii. Potential development agreement and annexation of the Neely tract on approximately 25.2 acres of land generally location at the southwest corner of FM 156 and Sam Reynolds Road in the extraterritorial jurisdiction of the Town.
- iv. Potential annexation and development agreement with Oneta Lee Cope Trust on a tract of land totaling approximately 69 acres generally located west of FM 156 and north of Sam Reynolds Road.
- v. Sports Venue Special Tax Election.
- vi. Potential Cost Sharing Agreement with City of Justin and Trininty River Authority for Wastewater Collection Pipeline.

B. Section 551.072 - Real Property

The Town Council may convene in an executive session to discuss or deliberate the purchase, exchange, lease, or value of real property if deliberation in an open meeting would have a detrimental effect on the position of the governmental body in negotiations with a third person.

- i. Regarding purchase, exchange, lease of value of real property to be acquired as right-of-way out of the following parent tract of 75.7 acres at northeast corner of FM 407 and Faught Road.
- ii. Regarding purchase, exchange, lease of value of real property to be acquired as right-of-way out of the following parent tract of 41.0 acres at southwest corner of SH 114 and Cleveland-Gibbs Road.

C. Section 551.087 - Economic Development Negotiations

The Town Council may convene in an executive session to discuss or deliberate regarding commercial or financial information that the Town has received from a business prospect that the Town seeks to have locate, stay, or expand in or near the Town and with which the Town is conducting economic development negotiations; or to deliberate the offer of a financial or other incentive to a business prospect described below.

i. Potential development agreement with Henry Northlake Development LLC on five tracts of land totaling approximately 122 acres generally located east of 1-35W and north of Denton Creek.
