- A. Hold a public hearing regarding the proposed annexation of approximately 1.157 acres of Dale Earnhardt Way right-of-way from State Highway 114 to approximately 300 feet north of Northport Drive within the Town's exclusive extraterritorial jurisdiction
(2nd Required Public Hearing; Final Consideration set for April 13, 2023)


4. ADJOURN
